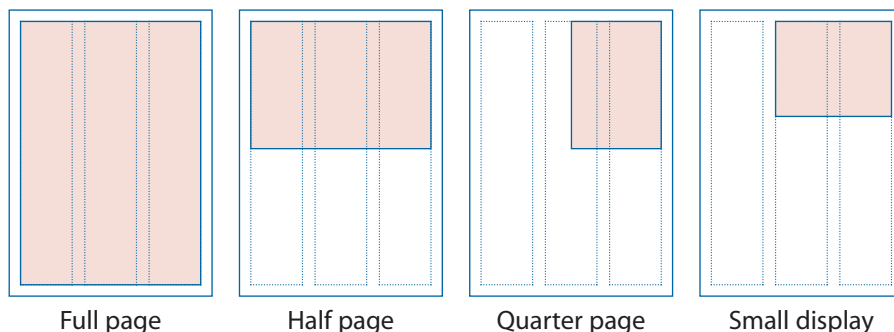

It is the responsibility of the advertiser to ensure this is the case.

3. Position and Omission

4. Cancellation by Advertiser

The publisher reserves the right to require 14 days' notice of any cancellations of any order or any unexpired part of any order.

5. Cancellation and Amendment by Publisher
